Dear Students,

By direction, it is to inform you that the institute is planning to conduct engineering remedial examinations for all semesters of the 2011-2017 admitted batch students at the campus from 27<sup>th</sup> September 2021 onwards.

The institute will make suitable precautionary measures against COVID-19. Also, students are informed to strictly adhere to the guidelines as mentioned below.

1. The boarding and lodging can be provided by the institute during remedial examination.

To get to the boarding and lodging facility the student must fill “Self-declaration form” attached with the follow link

The last date for submission of the self-declaration form (online) is 26/09/2021.

Based on your requirement provided in self-declaration, the accommodation will be provided at respective hostels.

The students pursuing the UG program currently are not necessary to pay the boarding and lodging charges.

The students who are passed out from the UG program (2011-2015 batches) have to pay the boarding and lodging charges.

An amount of **Rs. 100/- per day is charged** and is payable at “Director, RGUIIT-Nuzvid at State bank of India, A/C No. **40410774345** and **IFSC: SBIN0021233**.

The payment receipt has to attach in the “Self-declaration” form. A **payment receipt is compulsory (HARD COPY)** for giving accommodation.

2. Based on the details given in the self-declaration form, students are allowed to stay in the allocated hostel rooms.

(Student will be informed allotted room details by the office of Dean of Student Welfare)

3. It is mandatory to get tested for Covid-19 for boarding and lodging and should submit a Negative RT-PCR test report (**HARD COPY**) at the main entrance with the date of testing, not more than five days prior to the date of reporting.
4. In case you fail to submit the Negative RT-PCR test report during entry into the campus, you will be allowed to campus by conducting COVID test for which you have to pay Rs. 500/-.  
In case, the student tested with positive COVID-19, he/she will be kept in isolation in campus hospital and the parents have to take their wards to their home by arranging their own transport instead of public transport.
5. At the University entrance gate, the student must undergo an initial body temperature check and oxygen level check.

**Note:**

The student should duly inform the medical team about COVID symptoms if any.

If any abnormality is found in body temperature or oxygen saturation level, you will be allowed into the campus only if you test negative.

During your stay on the campus, the student must strictly follow the COVID protocols and other guidelines in Enclosure and disciplinary action will be initiated if you fail to follow protocols/Guidelines.

6. In case of any non-academic problems, students are informed to contact the caretakers/wardens.

**Note:**

Students who are currently affected with COVID-19 or COVID symptoms or in containment zone/red zone are informed not to report to the institute and such students may inform the Dean of Student Welfare Office.
